- Grant match for Bell Tower to obtain bells for the tower.....\$10,000.
- Establish mini grant program to repair dilapidated residential houses.....\$10,000.
- Aesthetic improvements to the downtown square for flower baskets, plaques, banners, banner arms, benches, trash cans, flowers, etc..... \$10,000.
