During Open Forum Charles Heimer spoke on outlets for appliances and concerns on water and sewer fees.

Ken Paxton spoke on J Corp Housing Project rental units being needed.

Sid Jones spoke on generation population and putting capital into projects that are needed. It was requested the City apply for a \$1 million grant from Iowa Financing Authority that would be repaid in 20 years if the City was to receive and decide to accept an award. The million dollars would be requested from the city by JCorp in the form of a \$625,000 grant and a \$375,000 loan for Phase 1 of their housing development to North Walnut Street.
